For healthcare professionals looking for a career overseas, you need to know your strengths and your target location. Doing research and having a plan in place will make finding the right job overseas more straightforward. Determine which countries your passport allows you to work in without securing a working visa before departure.<sup>3</sup> If you're fresh out of college, determine whether the country you're targeting welcomes workers with little to no experience. Hone in on a country or an association of countries (i.e., ASEAN, GCC, EU) so that your efforts are more concentrated, and therefore, more effective. You can, of course, target your 'dream destination'.

Some of you may dream of working in a particular country. Take, for instance, the USA. The American Dream has been part of the narrative for most migrant workers. For millennials, though, migration has expanded to the USA, and further afield. Your dream country may offer a standard of living better than in your home country.

It may also mean taking you away from all that is familiar because you are giving in to your wanderlust and immersing yourself in a completely new culture and way of life. Thoroughly research the requirements to get a working visa in your dream destination and find out if your home country has an existing bilateral relationship with the destination you are researching.

A good way to focus on a country or group of countries is to determine where your fellow compatriots have been or are going. If you have a college organization, which countries are most talked about when immigrating? In your healthcare worker forums on social media, which foreign cities are most discussed when hiring foreign workers? Most likely, the countries with the most number of migrant workers from your nation are the easiest to enter as part of the workforce. It may also be the country with the most demand for your profession. **Right Target** 



#### Agreements between countries

Most countries that export labor often have a Memorandum of Agreement (MOA) with the destination country. Be it arrangements for faster visa processing or easier requirements for employment, an official contract for the efficient deployment of migrant workers will exist.<sup>4</sup> Take, for example, the existing relationship between the Philippines and the Kingdom of Saudi Arabia (KSA).<sup>5</sup> There has been an influx of migrant workers to the Kingdom for decades. The bilateral agreement between the two countries was updated with the most recent MOA<sup>6</sup>. Amongst other things, both countries agreed to ensure the streamlining of job application processes. your path to getting a job in the KSA is a lot easier than getting a job in a country with no existing MOA with the Philippines. Filipinos have better opportunities within South East Asia, because of strong existing ties with the rest of the ASEAN member countries.<sup>7</sup> Right now, there are ten members of the ASEAN intergovernmental organization. They are Brunei, Cambodia, Indonesia, Laos, Malaysia, Myanmar, the Philippines, Singapore, Thailand, and Vietnam.

India also has an existing bilateral relationship with KSA. The country has an established process for healthcare workers wishing to work in the Kingdom.<sup>8</sup> If you are an Indian healthcare worker, you don't need to guess what the process is or what the requirements are anymore when applying for a KSA job.

In the European Union, EU citizens usually have freedom of movement within their member states. For example, most EU citizens can freely work in Switzerland and do not need to obtain a work permit, except for Croatian citizens.<sup>9</sup> For citizens outside the EU, the Union has an existing bilateral agreement with a select group of countries.<sup>10</sup>

Get information from your government's labor office about which countries have an existing bilateral relationship with them when getting a job abroad. Then concentrate your efforts on the countries you wish to work in.

O2 Research the Application Process





When applying for a job abroad, you do not have to reinvent the wheel. That road has been paved by the thousands of immigrants before you. As you have already chosen your target, it's time to acquire the necessary resources to bag that job. What are the processes that you need to undergo to secure employment in your target country? Are there several visa paths to choose? What credentials do you need in order to qualify for the position you are applying to? Are there government agencies set up in place to help facilitate your job application? Are there legal representatives that you need to go through to know which jobs are available? Do you need to undergo further training and/or certification? 12

## Basic documents needed

As an aspiring migrant worker, here are some of the basic requirements or documents that you need to prepare for your overseas job application:

Resumé / CV Valid Passport

Professional License

Work Experience Certificates

- College/University Diploma
- College/University Transcript of Records or Marksheet

Certificate of Good Standing (this may be required by some regulators abroad)

#### Internship Certificates (depending on the position you are applying for)

### Working visa requirements

When applying for a job abroad, most international employers assist you in procuring your working visa or work permit. They are most likely well-versed in the processes and the documentation required and can give you instructions on what you need to do.

If you decide to get a visa before getting an employer, there are many things to consider. Can your target country issue a working visa without an existing job contract? Do you need to be in or out of the country when applying for the visa? Is there more than one visa path for you? Are you looking for a working visa or citizenship? Depending on your credentials, ensure you have a clear understanding of the requirements and the visa paths that are open for you.

Let's review working overseas in Australia as an example. Australia has several visa subclasses for those wishing to work in their country. Twenty-four, to be exact.<sup>11</sup> You can opt to go the Regional Sponsored way, wherein a State can nominate you for a work visa if they have a shortage of skilled workers in your field. If you target a city that is not within the list of regional sponsors, you can opt to go the points-system route.<sup>12</sup>

### Gulf Cooperation Council (GCC) region and their requirements

For the GCC region countries, their requirements for healthcare workers are pretty much the same, with one or two differing conditions.<sup>13</sup> Once qualified to practice as a healthcare professional in one member country, you can transfer your credentials to another member country. A universal requirement for a medical worker in the GCC region is verified credentials in the form of a Primary Source Verified (PSV) report.<sup>14</sup> Credentials include your diploma, professional license, work experience, and some countries require a Certificate of Good Standing. A certification examination may be necessary, depending on a governing body's assessment of your credentials.



#### Present yourself as a qualified candidate

With your PSV report, you can fast-track your job application for a healthcare worker position. Most countries hiring healthcare professionals require a PSV report. For example, countries belonging to the GCC region need your PSV report before evaluating your eligibility to practice your profession and issuing you a license.<sup>15</sup> Although employers may shoulder the expense for verification, ultimately, they will employ a pre-verified candidate over a non-verified one.
